


2. The Shreyaann-Ishaan Education Society has applied for establishment of Homoeopathy College in the name of Hamsa Homoeopathy Medical College at Ksheerasagar (V), Mulugu (M), Medak District. On careful consideration of the proposal, the Government has decided to issue 'No Objection Certificate' to the applicant for the establishment of a Homoeopathy College with 100 (Hundred) seats for starting BHMS Course.

3. It is certified that :-

1. It is desirable to establish a Homoeopathy College in the public interest / starting BHMS course and,
2. Establishment of Homoeopathy College / Starting BHMS course at Ksheerasagar (V), Mulugu (M), Medak District is feasible.

4. It is also certified that adequate clinical material as per norms of the Central Council of Homoeopathy is available with the proposed Medical College. It is further certified that in case the applicant fails to create Infrastructure for the homoeopathy College as per Central Council of Homoeopathy norms and fresh admissions are stopped by the Central Government, the State Government shall take over the responsibility of the students already admitted in the College with the permission of the Central Government.
