In continuation to this Ministry's letter of even No. dated 15.09.2017 wherein a Letter of Permission was issued to the college to start a new Homoeopathic College in the name of Hamsa Homoeopathy Medical College, Hospital & Research Centre, Opp. ZP High School, Ksheerasagar, Mulugu (M), Siddipet (DT), Telangana with 100 seats in BHMS course under section 12 A of HCC Act, 1973 for academic year 2017-18, I am directed to say that in order to verify the compliance of the College, the Board of Governors to Central Council of Homoeopathy has conducted inspection of Hamsa Homoeopathy Medical College, Hospital & Research Centre, Opp. ZP High School, Ksheerasagar, Mulugu (M), Siddipet (DT), Telangana, on 27.06.2018 and furnished its recommendation as under:

"Recommended for not allowing admission in 1-BHMS course and not to allow continuation of II – BHMS Course for the session 2018-19 in view of deficiencies reflected in inspection report including- a) IPD bed occupany- 7.29% etc. (total number of patients in IPD during last one year is 666), b) Associate Professors have not been appointed in Anatomy, Physiology, Pharmacy, Pathology and FMT. c) Mummified body, Cadaver in Anatomy) only 1418 books. available against requirement of 2000. The committee further recommended for migration of students (allowed in previous year) to other nearby recognized Homoeopathic Medical College."

2. After considering the provisions of section 12C (1) of Homoeopathy Central Council (Amendment) Ordinance, 2018, HCC(MSR) Regulations, 2013, recommendations of the Board of Governors to CCH, observation of the Hearing Committee and Policy of the Central Government for granting conditional permission during the session 2018-19, permission of the Central Government is hereby granted to Hamsa Homoeopathy Medical College, Hospital & Research Centre, Opp. ZP High School, Ksheerasagar, Mulugu (M), Siddipet (DT), Telangana, for taking admissions in 1st BHMS course and continuation of 2nd BHMS Course with intake capacity of 100 seats for the academic year 2018-19 subject to condition that the college shall fulfill the following requirements by 31st December, 2018:



- All the Minimum Standard Requirements of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Homoeopathy Central Council (Minimum Standards Requirement of Homoeopathic Colleges and attached Hospitals) Regulations 2013" by 31st December 2018"; and
- All the requirements under the provisions of the HCC Act, 1973 and relevant Regulations made thereunder should be fulfilled in toto.
- 3. The college has to develop the requisite infrastructure for above said BHMS courses well in time as per the CCH norms which will be verified and reported by the CCH at least three months before the start of next professional and accordingly, the permission for taking admissions in subsequent academic session will be issued.
- 4. The college administration may take up the matter for recognition of the qualification under section 13(1) of the HCC Act, 1973 at that time when the first batch of students admitted against this course appears for the first final professional examination of the said course.
- 5. Please acknowledge the receipt of this letter.
