Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020. As per section 59 (2) of NCH Act, 2020, following has been stated:

“Notwithstanding the repeal of the Homoeopathy Central Council Act 1973, the educational and medical standards, requirements and other provisions of the Homoeopathy Central Council Act, 1973 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder: Provided that anything done or any action taken as regards the educational and medical standards and requirements under the enactment under repeal and the rules and regulations made thereunder shall be deemed to have been done or taken under the corresponding provision of this Act and shall continue in force accordingly unless and until superseded by anything or by any action taken under this Act”.

As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-I proforma were examined by the Medical Assessment and Rating Board.

2. On careful consideration of the report, the Medical Assessment and Rating Board has arrived at the following conclusion :-

That the applicant has set up a Homoeopathic Medical College with the component of staff, infrastructure, equipment and instruments and other facilities where as the College has to take urgent and time bound steps to implement Minimum Standard Requirements of the Homoeopathy College and attached Hospital as prescribed by the National Commission for

Homoeopathy for conducting BHMS course in Homoeopathy. The deficiencies reported are as follows.

A. Discrepancies in engagement of teachers: Item wise clarification may be provided after rectifying the anomalies.

1. Repertory Dr Sucharitha Amsole(Reader in Repertory)- The appointment may be clarified since the previous experience as Lecturer in Repertory is not complete(From 1-02-14 to 30-11-15, Lecturer Repertory, from 23-06-16 to 31-3-19, Senior Research Fellow, and Reader in Repertory from 25-05-19)
2. Practice of Medicine. Dr A Sudarshan (Professor, Community Medicine)- His age exceeded 40 yrs at the time of joining(DOB 5-10-56; Date of joining, Feb 2009); secondly previous experience from 2009-2019 was in Practice of Medicine and, he is Professor in Community Medicine from 19-04-19 till date
3. Dr Sucharitha Amsole(Read, Rep)- Previous experience as Lecturer in Repertory not Complete (From 1-02-14 to 30-11-15, Lecturer Repertory, from 23-06-16 to 31-3-19, Senior Research Fellow, and Reader in Repertory from 25-05-19).
4. Dr D. Gopal(Prof ANA)- His age exceeded 40 years at the time of joining (DOB 05-06-59; Date of joining, 28-01-09)
5. Dr Loka Leela(Professor Physiology) Age exceeded 40 years at the time of joining as Lecturer (DOB 5-10-63; Date of Joining, 19-10-10)
6. Dr K Kiran Kumar (Professor Pathology)- Professor, Pathology – May be clarified as his previous experience is in Physiology from 17-08-07 to 25-11-17. Joined as Professor in Pathology on 11-12-18.
7. Dr K. Samuel Sunil K ,Prof, Practice of Medicine. Appointment may be clarified since his previous experience is in Surgery and Physiology from 1984 to 26-03-21 and changed department from 27-03-21 as Professor of Practice of Medicine
8. Dr Karani R Hirji(Read, POM)- Age exceeded 40 years at the time of joining as Lecturer (DOB 15-12-68; Date of Joining, 09-06-09)

B. Hospital Staff

1. Resident house physician 1 available against the requirement of 02.
2. 2 Nursing staff are available against the requirement of 03.
3. Ward boy/Aya 3 are available against the requirement of 04.
4. X-ray tech, Nursing staff in charge, Yoga expert, Lab attendant, Secretarial staff, accountant, and Dietician are absent against the requirement of 01 each.

C. Teaching Faculty

23 full time teachers and 7 Guest teachers are available against the requirement of 28 full time and 12 Guest faculties.

- D. Website** –The College website is <http://www.hamsahomeopathy.org> as checked on dated 25.08.2021, Student data of 2020 -2021 is not available.

- E. Miscellaneous:** Form-16 of teachers, non teaching staff & hospital staff- 5 teachers, 02 hospital staff provided.

3. After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC(MSR) Regulations, 2013, **Conditional permission of the Medical Assessment and Rating Board is issued to Shreyaan Ishaan Educational Society's, Hamsa Homoeopathy Medical College, Hospital and Research Centre, Kasheersagar Village, Mulugu Mandal, Medak Distt.-502279, Telangana for continuing admissions in 1stBHMS course with intake capacity of 100 seats during the academic year 2021-22. The Principal is directed to fulfill the deficiencies within three months and an affidavit**


in this regard may be submitted to the Medical Assessment Board within a period of one week.

4. All admissions in Under Graduate course shall be through NEET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted thereunder.

5. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board as per rules.

6. The college has to comply with the full requirements of Minimum Standard Requirement Regulations, 2013 for conducting the course. All deficiencies observed and mentioned above which affects the performance of the academic Institution, through which College fails to fulfill the statutory requirements, has to be rectified within three months time from issue of this permission letter. Compliance report shall be submitted by the college to Medical Assessment and Rating Board accordingly. Subsequently, the Board shall verify the compliance well in time and may conduct Online/Physical inspection for verification of compliance as per the HCC (MSR) Regulation, 2013 and will consider admissions for the academic year 2022-23.
