This Memorandum of Understanding (MOU) is entered into on 13/09/2020 between Hamsa Homeopathy Medical College, Hospital & Research Centre, located at Ksheerasagar, Mulugu mandal, Siddipet Dist., Telangana hereinafter referred to as "the Organizer," and Vishwa Vishwani Institute of Systems and Management, Thumkunta, Telangana 500078, hereinafter referred to as "the Partner."

Purpose:

Scope of Work:

Responsibilities:

a. The Organizer:

- Recruits and manages a team of healthcare professionals and volunteers.
- Arranges for necessary medical equipment and supplies.
- Coordinates with local authorities to ensure compliance with regulations.

b. The Partner:

- Assists in publicizing the health camps within its network and community.
- Provides logistical support and facilitates access to suitable venues.
- Collaborates in the recruitment of volunteers and sponsors.

Duration:

This MOU shall be effective from / /2020 and remain in force for a period of 05 years, unless terminated by mutual agreement or due to unforeseen circumstances.

Financial Arrangements:

Both parties agree to discuss and agree upon any financial contributions or responsibilities associated with the health camps.

Confidentiality:

Both parties agree to treat any sensitive information shared during the collaboration with the utmost confidentiality and not disclose it to third parties without the written consent of the other party.

Termination:

Either party may terminate this MOU with written notice of 30 days in case of a breach of terms or due to unforeseen circumstances.

This MOU represents the understanding between the Organizer and the Partner for conducting health camps and is not legally binding until signed by both parties.
