Sir,

Medical Assessment and Rating Board for Homoeopathy has examined the documents of compliance submitted by the college to start new post graduate course in M.D (Hom.) with 42 seats in the 7 subjects with 06 seats in Materia Medica, Homoeopathic Pharmacy, Repertory, Practice of Medicine, Organon of Medicine, Pediatric and Psychiatry in in Shreeyan Ishaan Educational Society, Hamsa Homoeopathy Medical College Hospital & Research Centre, Sy No. 617, 618, Opp. ZPHS High School, Ksheerasagar, Mulugu, Siddipet, Telangana 502279 for academic session 2023-2024 as per the prevailing regulations under NCH Act, 2020.

On careful consideration of the compliance, the Medical Assessment and Rating Board has arrived at the following conclusion:-

- A. University approved guide list shall be submitted.
- B. The College shall submit UG and PG faculty list. Faculty for PG appointment, joining letter and experience certificate shall be submitted.
- C. Website shall be updated with all UG & PG staff list, hospital and OPD/IPD status.

After considering the provisions of section in NCH Act 2020 and its relevant regulations Permission of the Medical Assessment and Rating Board is issued to open/Start a new Higher MD (Hom) course 42 seats in 7 subjects with 06 seats in Materia Medica, Homoeopathic Pharmacy, Repertory, Practice of Medicine, Organon of Medicine, Pediatric and Psychiatry in Shreeyan Ishaan Educational Society, Hamsa Homoeopathy Medical College Hospital & Research Centre, Sy No. 617, 618, Opp. ZPHS High School, Ksheerasagar, Mulugu, Siddipet, Telangana 502279 for academic year 2023-24. The Principal is directed to fulfill the deficiencies within 30 days and an affidavit in this regard may be submitted to the Medical Assessment Board within a period of 15 days.

The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board as per Rules. The College has to comply with the full requirements of NCH Act 2020 and its relevant regulations for conducting the course.

All admissions shall be made from AIAPGET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS (UG) and PG Course course shall be treated as All India Quota. The counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/UT Government as designated by Central Government/NCH for the academic year 2023-24 and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central government/NCH for All India quota or the students admitted thereunder.

The Board shall verify the compliance well in time and may conduct Online/Physical inspection for verification of compliance as per the NCH Act 2020 and will consider admissions for the academic year 2023-24.
